Dosage & Administration

Store in dark at $35\text{--}46^{\circ}$ F (2–8° C). Do not freeze.

Use entire contents when first opened.

Do not vaccinate within 21 days before slaughter.

Uses





The product contains PCV2a, and has been shown to be effective against lymphoid depletion, inflammation and colonization of lymphoid tissue, and the magnitude of viremia.

Precautions: Store out of direct sunlight at 35 - 46°F (2 - 8°C). Do not freeze. Use entire contents when first opened. Do not vaccinate within 21 days before slaughter. Do not mix with other products. In case of anaphylactoid reaction, administer epinephrine. This product has not been tested in pregnant animals. In case of human exposure, contact a physician.
